# OHIO EPA—2019 WATER POLLUTION CONTROL LOAN FUND PROGRAM MANAGEMENT PLAN

\* Ohio EPA is offering up to \$36.1 million in principal forgiveness to communities to upgrade or connect failing household sewage treatment systems, to promote regionalization efforts, to correct combined sewer overflows and unsewered areas and to promote backup power facilities.

## PROGRAM SPOTLIGHT: WATER POLLUTION CONTROL LOAN FUND

Do you or anyone you know have problems with a septic system or aerator?

Through a grant from the Ohio EPA, Pickaway County Residents may quality for funding assistance to repair or replace their system if they have a household sewage treatment system that has failed, is failing or is in need of repair. To qualify for this assistance:

- The home must be owner occupied (no rentals, new builds, or foreclosures).
- The system must be documented as failed by PCGHD.
- The owner must be income eligible

#### STORIES FROM THE FIELD

During the summer months, our office receives a high number of complaints. Calls regarding poor housing conditions seem to be on the rise. We received a complaint from a family this past summer who was renting a home and their basement had flooded with sewage. Their landlord had neglected to address the issue and they had small children in the home. Their home was connected to public sewer. Our office has very little authority over interior housing conditions, but due to the inherent risks of the situation we made it a priority to investigate. Odors from sewage can cause harmful health effects. We contacted the Pickaway County Building Department, who met us on site. They identified the problem as being a blocked or damaged building drain. The family's laundry that was in the basement at the time was soaked through with sewage water and there were a few inches of standing liquid in the basement. We were able to cite ORC 3707.01, regarding plumbing which is in a condition dangerous to life or health. We sent a notice of violation to the landlord, who had the drain fixed and the basement cleaned within one week.

#### ENVIRONMENTAL HEALTH

The Environmental Health Division is responsible for licensing and inspecting local food service operations, retail food establishments, campgrounds, public pools and spas, and local food vendors in Pickaway County. The division also permits and inspects private water systems and residential sewage systems installed in the county. The Environmental Health Division responds to nuisance complaints and animal bite reports. The division inspects public and private schools in the county. The division works with the Ohio EPA to inspect semi-public sewage systems for businesses and commercial properties and administers the solid waste program for the county.

#### **News and Updates**

The Environmental Health Division has been busy with a recent survey of our Food Safety Program. This survey is conducted by the Ohio Department of Health (ODH). It involves staff from ODH conducting an intensive review of our food inspection records, as well as accompanying our sanitarians on some of their inspections. While we are still waiting on the final results, it was clear from the ODH staff person that our environmental health staff are running a quality program. This is another example of how our staff works hard to protect the health of the residents of Pickaway County.

#### CLINICAL HEALTH SERVICES

The primary goal of the Clinical Services division is to promote healthy lifestyles through community planning, health education, and public health nursing services. These services are tailored to meet the community health assessment concerns and needs.

#### **News and Updates**

Ohio has seen an increase in Hepatitis A this year. As of December 31, 2018 there have been 1,311 cases in Ohio. Sixty-six counties have confirmed cases, including Pickaway County.

Health Officials urge residents to take the proper precautions to prevent Hepatitis A. Hepatitis A is vaccine-preventable. If exposed you could have symptoms such as, fatigue, low appetite, stomach pain, nausea, and jaundice. These usually resolves within 2 months of infection.

#### CHILDREN WITH MEDICAL HANDICAPS

Our Children with Medical Handicaps (CMH) program is designed to link families of children with medical handicaps and special needs care to a network of qualified providers helping families pay for the medical services their child needs. A public health nurse (PHN) assist families to connect with CMH providers. CMH works with doctors and other health care providers to ensure that every child with a special health care need will have a medical home and case management.

The Pickaway Partners for Community Health Improvement (PPCHI) is a group of stakeholders in the community who have come together to identify and address the health needs of the county. The PPCHI Vision is "A Health Community."

#### **News and Updates**

One of the objectives of the PPCHI was to identify a model 2-1-1 system that can provide information and referral services for Pickaway County residents. The group has identified Pathways of Central Ohio (based out of Newark) to provide this service. Beginning in 2019, Pathways will operate a 2-1-1 system for Pickaway County 24 hours a day, seven days a week. 2-1-1 is one simple, easy-to-remember number to connect residents to all the help and information they need. Just like 9-1-1 eliminated the need to remember the number to call the fire and police, 2-1-1 is the number to dial when you want to be connected to a wide variety of social, human and governmental services.
